At the time that the metro district accepts new roads and infrastructure, each unimproved lot in that phase will be billed Infrastructure Maintenance and snowplowing fees on a pro-rated basis for the remainder of the year. These fees are billed to each unimproved lot once a year in January and monthly to improved lots. At the time that a meter is installed, the lot owner will be credited the pro-rated amount of Infrastructure Maintenance fees for that year and the Metro District will begin billing for utilities.

Scheduled Discontinuance of Service per Customer Request

Upon receipt of written request, service will be discontinued within 24 hours. Upon discontinuance of services, the customer will be billed the established monthly infrastructure maintenance fees, base water and sewer fees. Service will be re-established upon written request provided account is current.

Unscheduled Discontinuance of Service required by the District

Upon receipt of a 72 hour shut off notice, if payments are not received within 72 hours service will be discontinued. Upon discontinuance of services, the customer will be billed the established monthly infrastructure maintenance fees, base water and sewer fees and all interest and penalty charges. Service will be re-established when the district receives full payment.

Road Snow Plowing Fee

\$72.00 per year billed monthly at \$6.00/ per month.

Delineation of Responsibilities for Water and Sewer Line Maintenance and Repairs

Water Service:

- The property owner is responsible for the maintenance and repair to the water supply line from the outlet side of the meter to the residence.
- Edgemont Ranch Metro District is responsible for the water supply line from the outlet side of the meter back to the main supply line in the road. This excludes negligent or malicious actions by the property owner or their agents.

Sewer Service:

- The property owner is responsible for the maintenance and repair of the sewer line from the residence to the collector sewer line. The responsibility includes the tap splice on the line.
- Edgemont Ranch Metro District is responsible for the collector and trunk sewer lines excluding the tap splice for residential service. This excludes negligent or malicious actions by the property owner or their agents.

Water and Sewer Lines

Inspection fees \$25.00

Unauthorized Turn On Of Service

To re-establish service contact the District. Unauthorized water turn on will result in a \$1000.00 surcharge.

Unauthorized Water or Sewer Taps

The district will charge the responsible party a \$5000.00 fine per occurrence.

Late Plat Filing

The district will charge the responsible party a \$250.00 per day late fee if final plat is not received by the District within 5 business days after La Plata County filing.

Unauthorized Dumping Penalty

The district will charge the responsible party a fine of \$25,000.00 per occurrence for any unauthorized dumping into the District’s water or sewer systems.

Late Penalties, Collection Fees and Water Shut Off

1.38% interest per month will be charged to all accounts when payment is not received by the due date. If delinquent, in addition to the interest charge there will be 2% per month delinquency fee. Customer will be responsible for any and all collection expenses including but not limited to legal fees, collection charges, and delinquency charges. An account that remains delinquent for 60 days may be subject to shut off. Customer will receive 72 hours notice and, if requested, a hearing with the Metro District board. There is a \$50.00 shut off notice fee. Any account delinquent for more than 90 days may be subject to a lien on the respective property.
